Medical Release: Your signature below authorizes Word of Life Academy to contact (at your expense) a physician to render necessary emergency treatment for serious injury or accident if neither parent/guardian can be reached. This further authorizes Word of Life Academy to take your child to a local physician of the school's choice if your physician is not available. In the event that emergency treatment is necessary, Word of Life Academy will be held harmless in all decisions. In case of disaster, your child will only be released to those persons listed in the emergency information section.

The parent agrees to notify the school immediately when their child has been diagnosed with a contagious illness. Upon having a contagious disease the child must have written consent from either a physician or the Health Dept. to return to school.

The parent also agrees to keep their child at home if the child is sick. The school agrees to notify the parent/guardian whenever the child becomes ill at school, and parent/guardian agrees to pick up the child as soon as possible thereafter. In the event a child is sent home with a temperature of 100 degrees or higher, the parent agrees to keep the child home until a normal temperature has been maintained without medication for 24 hrs.

All medication must be brought to the preschool office accompanied by a separate Medication Permission Form before any medication will be administered. In the event of fever or illness I authorize the school staff to administer one dose of children's Tylenol until the child can be picked up.

I also agree to abide by all policies and procedures as stated in the Parent/Student Handbook.

Preschool Financial Policy/Parental Agreement

Tuition Deposit: The first week of tuition must be submitted with the application and is non-refundable.

Monthly Statements: All fees and charges will be itemized for you on a monthly statement which will be sent each month from the accounting office.

Tuition: Tuition is calculated on an annual basis and payments are based on the payment plan you select. Tuition is charged only for the days school is open and days that child care is available. Holidays and days we are closed and do not offer childcare are not included in the tuition. No refunds will be given in the case of illness, absence, holidays, or suspension.

Payments: Payments for tuition and other fees are due on Monday of each week (*unless an optional plan has been selected*). All accounts with an unpaid balance will be considered delinquent on Friday of each week and will consequently have a late payment fee assessed. Student absence is not a valid reason for late payments. Any family whose account is not paid in full within 14 days will not be permitted to return to WLCA until the account is made current. WLCA reserves the right to demand payment by the last day of the grace period (Friday of each week) from families who are consistently delinquent. After that time any missed payment will result in the student's *permanent dismissal*. All fees must be paid by check, cash, or money order. The first week of tuition must be paid before a child can begin school. No third-party checks can be accepted.

Mailing Payments: If you are mailing your tuition payments, please allow seven days for your payment to arrive in our office before the due date. Mailed payments received after Friday of each week will be subject to the late payment fee.

Late Fees: All accounts are subject to a late fee of 10% of any past due balance, with a minimum fee of \$15, that will be assessed on Friday of each week.

Returned Checks: As a result of a returned check your account will be assessed a charge for the amount of the returned check, as well as a \$35.00 returned check fee. Additionally, the use of personal checks for payment will be revoked and future payments will only be accepted in the form of cash, money order, or Cashier's check.

Withdrawals: Intent to withdraw a student must be made to the Preschool Director in writing and at least two weeks in advance. Failure to do so will result in an additional two weeks of charges reflected on the bill. No exceptions will be made.

Dismissal: If a student is permanently dismissed for any reason, parents remain responsible for ensuring payment is made for services rendered while their child was still in attendance.

Collections: If your account balance should become delinquent and remain delinquent for a period of forty-five (45) days, the administration reserves the right to refer the account to a collection agency. In the event an account is referred to a collections agency, collection fees in an amount not less than 33% of the delinquent balance shall be added to the account.

Records: All student records, including health records, will not be released until the account is paid in full and only after final payment clears the bank if made in the form of a check. All requests must be made in writing and allow a minimum of two full business days for processing.

Program Changes: Changes requested in program scheduling must be submitted in writing to the Preschool Director for approval before any changes can be made with the Bookkeeper.

Billing Changes: Changes requested in billing must be made in writing and submitted to the Bookkeeper.

Late Pick Up: If a child is picked up past 6:00 p.m. (12:00 p.m. for half day students) a late fee of \$15.00 will be applied every 10 minutes or fraction thereof. Late fees will be added to the statement on Friday of each week.

Sick Policy: Any child with a fever, vomiting, or other serious condition must be picked up by a parent or other authorized individual in a maximum of one and a half hours (1½) from the time the parent is contacted.

Legal Fees: All legal fees, collection fees, attorneys' fees, collection costs and any additional fees incurred by the school in an effort to settle disputes connected to this account shall be the sole responsibility of the parent or guardian for which this agreement is made.

Continual Conflict: In the event a child, or the parent of a child, continually causes disagreements, conflicts, strife, or arguments, the child shall be dismissed from the school without legal recourse.

Arbitration: If a legal issue, disagreement, conflict, problem, injury, injustice, or any other legal dispute should arise between the school, or one of its agents and a child, or parent of a child to binding arbitration with a non-partial arbitration party (party to be named in each individual case) for the settling of all issues.

Parent/Student Handbook: I agree to abide by all policies outlined in the Preschool Parent/Student Handbook.

I have read the above financial policy/parental agreement and fully agree to abide by the policy as set forth in its entirety. I understand that this financial policy/parental agreement will be strictly enforced. I agree to pay all financial obligations to Word of Life Christian Academy promptly and in a timely manner. I understand that I will have the late fees added to my account if the payment is not made within the grace period. I agree to uphold the rules and regulations of Word of Life Christian Academy as set forth in the Parent/Student Handbook. I will support the school's discipline by administering discipline in the home as needed. Also, in signing this agreement, I give consent for my child to participate in all field trips and school programs unless I notify the administration in writing otherwise. I understand the school will keep me informed of field trips and school activities well in advance. I also agree not to bring my child to school if full payment of my balance has not been made by the due date.

Preschool Discipline Policy

Word of Life Christian Academy believes in discipline that is firm, yet loving. Our objective of discipline is to help your child learn both self-control and expression of their feelings in socially acceptable ways. Students are expected to act in a manner which is conducive to learning and to the smooth functioning of school activities. Word of Life Christian Academy students are expected to respect the rights of their fellow students, to learn to live in a safe and pleasant environment while at school and at school sponsored activities and to respect members of the school staff. Limitations are clearly defined and consistently maintained. If a child does not follow teacher direction or the rules of the school then disciplinary action will be taken.

Word of Life Academy does not exercise any form of corporal punishment.

Teachers use positive reinforcement—recognition for good behavior, as a means of classroom control. Consequences of inappropriate behavior for preschool students may include the following:

- Re-direction—directing the child’s attention to other areas of interest to avoid behavior problems.
- Quiet time—time away from the other children to refocus on appropriate behavior. Quiet time will be appropriate to the child’s age (1 minute per year, i.e. age three, 3 min.).
- Loss of privileges—computer time, center time, etc.
- Children who are disruptive during rest time will be brought to the office to complete their rest period.
- Office visit—persistent or severe misbehavior will result in a visit to the office to discuss the problem with the director. A disciplinary note will be sent home. This may include a phone call to the parent.
- Parent conference—when the child refuses to change his/her behavior after reasonable attempts have taken place, the teacher or director will request a conference with the parents to discuss the problem and how the teacher and parent can work together to solve the problem. Progress reports will be sent home to keep the parents informed of the child’s progress.

Termination

A student may be terminated from school for a serious breach of conduct, and/or repeated problems with behavior. In the case of such an offense, the matter will be referred to the administrator who will then make a decision as to expulsion. The administrator has the authority to terminate any student for non-compliance with the rules and regulations of the school. Children may also be terminated if they suffer severe separation anxiety or are not fully potty trained.

I/we understand that there are risks/dangers involved with participation in off-campus trips and their associated activities. In consideration of my child being allowed to participate in this event, I/we agree to assume responsibility for those ordinary and reasonable risks associated with the travel and activities. I/we agree to hold harmless Word of Life Christian Academy, its affiliated organizations, employees, agents, and representatives, including volunteer and other drivers, from any and all claims arising from my child's participation. This release agreement does not apply to claims of intentional (criminal) misconduct or gross negligence by the school, its employees, or volunteers. If such circumstances are proved in a court of law, I/we acknowledge and agree that the school can assume no financial liability beyond its actual liability insurance policy in force.

In case of accident, illness, or other emergency, I/we request that the school contact me. If the school cannot reach a parent/guardian after conscientious effort, I/we give permission for school staff to call paramedics or any licensed physician or dentist. If a life-threatening emergency exists, I/we give permission for school staff to call paramedics immediately and then contact me/us as soon as possible thereafter.

I/we authorize and consent to any X-ray examination, anesthetic, medical, dental, or surgical diagnosis or treatment, and hospital care which, in the best judgment of a licensed physician or dentist, is deemed advisable. I/we agree to assume the financial responsibility for expenses incurred as a result of those services being provided. I/we also agree to be financially responsible for emergency medical transportation.

Philosophy

Word of Life Christian Academy (WLCA) is a ministry of Word of Life Assembly of God Church. As a ministry of the church, WLCA will support the vision, goals, and objectives of the Church. This means that WLCA, its employees, faculty, staff, and student body will operate in full harmony with the ministry and programs of the Church. Facilities will be shared equitably between the Church and all its affiliated ministries. This includes the principle of shared usage and accountability for all Word of Life Church assets and property. All assets, to include property and supplies are owned and administered by Word of Life Assembly of God Church. This philosophy of shared values between WLCA and the Church and the philosophy that WLCA is a ministry of the Church is the guiding principle, which shall direct and influence all business and academic decisions relating to the operation of WLCA. The educational philosophy of WLCA is based on a God-centered view that all truth is God's truth, and that the Bible is the inspired and infallible authoritative Word of God, which contains this truth. Our aim is to provide a Christian perspective on the total worldview. The philosophy ensures a balanced personality and a proper understanding and acceptance of a person's role in life at home, at work, at play and at worship, all grounded in Christian principles.

This philosophy channels our energies to promote high academic standards while helping the students to achieve skills in creative and critical thinking using the best integrated curriculum available. The objective of our instructional program is to enable the student to pursue the post-secondary education of their choosing, whether in college, university or in vocational training areas.

The Academy's responsibility to the student encompasses the spiritual, mental, intellectual, physical, social and emotional areas. Therefore, our aim is to teach spiritual values in all areas of curriculum. Spiritual values are woven throughout the total curriculum. All activities we employ or permit in the classroom or school program will either facilitate or reinforce this Christian education philosophy. The spiritual must permeate all areas, lest we become textbook oriented rather than student oriented.

This philosophy dictates that we cooperate closely with parents in every phase of the student's development, always offering assistance in understanding the purpose of WLCA.

Certain objectives are established in order to implement this philosophy.

To teach that the Bible is the inspired and the only infallible authoritative Word of God, thus developing attitudes of love and respect toward it (II Timothy 3:15-17; II Peter 1:20-21).

To provide opportunities for the student to confess Christ as Savior and Lord (Romans 10:9-10).

To teach Biblical character qualities and provide opportunities for the student to demonstrate these qualities (I Samuel 16:7; Galatians 5:22-23).

To teach the students how to develop the mind of Christ towards godliness (Philippians. 2:5; I Timothy. 4:7)

To encourage the student to develop self-discipline and responsibility from God's perspective (I Timothy 4:7; I Corinthians 9:24-27).

To teach the student the respect for and submission to authority from God's perspective (Romans 13:1-7; Hebrews 13:17; Ephesians 6:1-3).

To help the student develop a Christian worldview by integrating life, and all studies, with the Bible (II Peter 1:3).

To teach the student to hide God's Word in his heart through memorization and meditation (Psalms 119:11; Psalms 1:1-3)

To help the student develop his identity in Christ as a unique individual created in the image of God and to attain his fullest potential (Psalms 139:13-16).

To teach the student to treat everyone with love and respect as unique individuals created in God's image (Philippians 2:1-4; Ephesians 5:21).

To teach the student how to become a contributing member of his society by realizing his need to serve others (Galatians 5:13; Romans 2:10).

To teach the student physical fitness, good health habits, and wise use of the body as the temple of God (I Corinthians 6:19-20).

To teach the student Biblical attitudes toward material things and his responsibility for using them to God's glory (I Timothy 6:17-19; Matthew 6:19-20; I Corinthians 10: 31).

To teach the student to understand and use fundamental processes in communicating and dealing with others [such as reading, writing, speaking, listening, and mathematics] (II Corinthians 5:20).

To teach and encourage the student to use good study skills and habits (II Timothy 2:3-7).

To teach the student how to research and to reason logically from a Biblical perspective (Hebrews 5:14; Romans 12:2).

To teach the student good citizenship through an understanding and appreciation of our Christian and American heritage's [home, church, and nation] (I Corinthians 10:11; Romans 13:1-7).

To cooperate closely with the parents in every phase of the student's development, especially as it relates to the school program (Mark 10:45).

To help the parents to understand the school's purpose and program.

To encourage parents to realize and shoulder their responsibility for the spiritual, moral, and social education of their children (Deuteronomy 6:4-7, Proverbs 22:6).

This Philosophy of Christian Education for WLCA shall be the guiding tool for applying Biblical principles to teaching practices. Any use of materials or practices inconsistent with this Philosophy of Christian Education will not be permitted. The Board shall apply this Philosophy of Christian Education in all Board meetings. All WLCA faculty and staff members shall apply this Philosophy of Christian Education in their daily work for WLCA. Employees shall be committed to fulfilling the principles outlined in the Philosophy of Christian Education in every reasonable way possible. Unwillingness to adopt and promote these basic Christian education principles is grounds for dismissal.

Statement of Faith

Word of Life Christian Academy (WLCA) is a ministry of Word of Life Assembly of God Church (WOLAG). The Statement of Faith for both WLCA and the Church is recorded in the Constitution and Bylaws of Word of Life Assembly of God Church, Springfield, VA.

The Scriptures Inspired. The Scriptures, both Old and New Testaments, are verbally inspired of God and are the revelation of God to man, the infallible, authoritative rule of faith and conduct (II Timothy 3:15-17; I Thessalonians 2:13; II Peter 1:21).

The One True God. The one true God has revealed Himself as the eternally self-existent "I AM," the Creator of heaven and earth and the Redeemer of mankind. He has further revealed Himself as embodying the principles of relationship and association as Father, Son, and Holy Ghost (Deuteronomy 6:4; Isaiah 43:10, 11; Matthew 28:19; Luke 3:22).

The Deity of the Lord Jesus Christ. The Lord Jesus Christ is the eternal Son of God. The Scriptures declare:

His virgin birth (Matthew 1:23; Luke 1:31-35).

His sinless life (Hebrews 7:26; I Peter 2:22).

His miracles (Acts 2:22; 10:38).

His substitutionary work on the cross (I Corinthians 15:3;

II Corinthians 5:21).

His bodily resurrection from the dead (Matthew 28:6; Luke 24:39; I Corinthians 15:4).

His exaltation to the right hand of God (Acts 1:9, 11; 2:33; Philippians 2:9-11; Hebrews 1:3).

The Fall of Man. Man was created good and upright; for God said, "*Let us make man in our image, after our likeness.*" However, man by voluntary transgression fell and thereby incurred not only physical death but also spiritual death, which is separation from God (Genesis 1:26, 27; 2:17; 3:6; Romans 5:12-19).

The Salvation of Man. Man's only hope of redemption is through the shed blood of Jesus Christ, the Son of God.

Conditions of Salvation: Salvation is received through repentance toward God and faith toward the Lord Jesus Christ. By the washing of regeneration and renewing of the Holy Ghost, being justified by grace through faith, man becomes an heir of God according to the hope of eternal life (Luke 24:47; John 3:3; Romans 10:13-15; Ephesians 2:8; Titus 2:11; 3:5-7).

The Evidence of Salvation: The inward evidence of salvation is the direct witness of the Spirit (Romans 8:16). The outward evidence to all men is a life of righteousness and true holiness (Ephesians 4:24; Titus 2:12).

The Ordinances of the Church.

Baptism in Water: The ordinance of baptism by immersion is commanded in the Scriptures. All who repent and believe on Christ as Savior and Lord are to be baptized. Thus they declare to the world that they have died with Christ and that they also have been raised with Him to walk in newness of life (Matthew 28:19; Mark 16:16; Acts 10:47-48; Romans 6:4).

Holy Communion: The Lord's Supper, consisting of the elements—bread and the fruit of the vine—is the symbol expressing our sharing the divine nature of our Lord Jesus Christ (II Peter 1:4); a memorial of His suffering and death (I Corinthians 11:26); and a prophecy of His second coming (I Corinthians 11:26); and is enjoined on all believers "till He come!"

The Baptism in the Holy Ghost. All believers are entitled to and should ardently expect and earnestly seek the promise of the Father, the baptism in the Holy Ghost and fire, according to the command of our Lord Jesus Christ. This was the normal experience of all in the early Christian Church. With it comes the endowment of power for life and service, the bestowment of the gifts and their uses in the work of the ministry (Luke 24:49; Acts 1:4, 8; I Corinthians 12:1-31). This experience is distinct from and subsequent to the experience of the new birth (Acts 8:12-17; 10:44-46; 15:7-9). With the baptism in the Holy Ghost come such experiences as an overflowing fullness of the Spirit (John 7:37-39; Acts 4:8), a deepened reverence for God (Acts 2:43; Hebrews 12:28), an intensified consecration to God and dedication to His work (Acts 2:42), and a more active love for Christ, for His Word, and for the lost (Mark 16:20).

The Evidence of the Baptism in the Holy Ghost. The baptism of believers in the Holy Ghost is witnessed by the initial physical sign of speaking with other tongues as the Spirit of God gives utterance (Acts 2:4). The speaking in tongues in this instance is the same in essence as the gift of tongues (I Corinthians 12:4-10, 28), but different in purpose and use.

Sanctification. Sanctification is an act of separation from that which is evil, and of dedication unto God (Romans 12:1-2; I Thessalonians 5:23; Hebrews 13:12). The Scriptures teach a life of "*holiness without which no man shall see the Lord*" (Hebrews 12:14). By the power of the Holy Ghost we are able to obey the command: "*Be ye holy, for I am holy*" (I Peter 1:15-16).

The Church and Its Mission. The Church is the Body of Christ, the habitation of God through the Spirit, with divine appointments for the fulfillment of her great commission. Each believer, born of the Spirit, is an integral part of the General Assembly and Church of the Firstborn, which are written in heaven (Ephesians 1:22-23; 2:22; Hebrews 12:23). Since God's purpose concerning man is to

seek and to save that which is lost, to be worshipped by man, and to build a body of believers in the image of His Son, the priority reason-for-being of the Assemblies of God as part of the Church is:

To be an agency of God for evangelizing the world (Acts 1:8; Matthew 28:19-20; Mark 16:15-16).

To be a corporate body in which man may worship God (I Corinthians 12:13).

To be a channel of God's purpose to build a body of saints being perfected in the image of His Son (Ephesians 4:11-16; I Corinthians 12:28; 13:12).

The Assemblies of God exists expressly to give continuing emphasis to this reason-for-being in the New Testament apostolic pattern by teaching and encouraging believers to be baptized in the Holy Spirit. This experience enables them to evangelize in the power of the Spirit with accompanying supernatural signs (Mark 16:15-20; Acts 4:29-31; Hebrews 2:3-4).

Adds a necessary dimension to worshipful relationship with God (I Corinthians 2:10-16; 12:13-14).

Enables them to respond to the full working of the Holy Spirit in expression of fruit and gifts and ministries as in New Testament times for the edifying of the body of Christ (Galatians 5:22-26; I Corinthians 14:12; Ephesians 4:11, 12; I Corinthians 12:28; Colossians 1:29).

The Ministry. A divinely called and scripturally ordained ministry has been provided by our Lord for the threefold purpose of leading the Church in:

Evangelization of the world (Mark 16:15-20).

Worship of God (John 4:23-24).

Building a body of saints being perfected in the image of His Son (Ephesians 4:11-16).

Divine Healing. Divine healing is an integral part of the gospel. Deliverance from sickness is provided for in the atonement, and is the privilege of all believers (Isaiah 52:4-5; Matthew 8:16-17; James 5:14-16).

The Blessed Hope. The resurrection of those who have fallen asleep in Christ and their translation together with those who are alive and remain unto the coming of the Lord is the imminent and blessed hope of the Church (I Thessalonians 4:16-17; Romans 8:23; Titus 2:13; I Corinthians 15:51-52).

The Millennial Reign of Christ. The second coming of Christ includes the rapture of the saints, which is our blessed hope, followed by the visible return of Christ with His saints to reign on the earth for one thousands years (Zechariah 14:5; Matthew 24:27, 30; Revelation 1:7; 19:11-14; 20:1-6). This millennial reign will bring the salvation of national Israel (Ezekiel 37:21-22; Zephaniah 3:19-20; Romans 11:26-27) and the establishment of universal peace (Isaiah 11:6-9; Psalms 72:3-8; Micah 4:3-4).

The Final Judgment. There will be a final judgment in which the wicked dead will be raised and judged according to their works. Whosoever is not found written in the Book of Life, together with the devil and his angels, the beast and the false prophet, will be consigned to everlasting punishment in the lake which burneth with fire and brimstone, which is the second death (Matthew 25:46; Mark 9:43-48; Revelation 19:20; 20:11-15; 21:8).

The New Heavens and the New Earth. *"We, according to His promise, look for new heavens and a new earth, wherein dwelleth righteousness"* (II Peter 3:13; Revelation 21, 22).

We recognize that certain teachings are left primarily to other Church ministries and the home.

Open opposition to these basic Christian Statements of Faith is grounds for dismissal.

ADMISSION REQUIREMENTS FOR PRESCHOOL

Thank you for your interest in Word of Life Christian Academy's Preschool Program. Choosing the right preschool for your child is a tremendous responsibility. It is at this early age that children learn the foundational concepts they will need as they continue to grow and develop into young adults. At Word of Life Christian Academy we are devoted to providing a challenging educational program so that you may have opportunity to secure the best education possible for your child. All children will be considered for admission regardless of race, color, or national and ethnic origin. Our preschool program admits children who are at least 2 ½ years (30 months) of age through the age of five. Enrollment will depend upon available space in the classroom, the child's social maturity, and readiness for the school program. Listed below you will find the requirements for admission into our school. If you need additional assistance throughout the admissions process, please feel free to contact the school at 703-354-4222.

BEFORE APPLYING FOR ADMISSION:

1. Your child must be at least 30 months (2 ½ yrs.) of age

All children entering a pre-school class must be at least 30 months (2 ½ yrs.) old before they can attend. All children entering a pre-kindergarten class must be 4 years old on or before September 30th. Because our school is an accredited school we cannot make allowances for late birthdays.

2. Your child must be FULLY potty trained.

We define this as no more than one (1) accident per week. Children may not wear diapers or pull-ups to school. If after admission we find that the child is not fully potty trained, his/her enrollment will be terminated.

3. Your child must be able to feed him/herself.

Children must be able to feed themselves. Teachers do not spoon feed children. Baby bottles, pacifiers and sippy cups are not permitted.

AFTER MEETING THE PREVIOUS REQUIREMENTS:

STEP 1: Fill out the application for enrollment and submit it to the Preschool Director. (*Tuition Deposit must accompany application to be considered for enrollment.*)

The application for enrollment includes a copy of our Philosophy, Statement of Faith, Discipline policy and Financial Agreement forms. All forms must be signed. The non-refundable tuition deposit must accompany the application. This fee reserves a space for your child until the admission process is completed or for a maximum of thirty days. Until the admission process is complete, your child is not considered enrolled in our school. The tuition deposit is only refunded if we do not accept your child into Word of Life Academy.

STEP 2: Set up an Interview with the Director.

After the application for enrollment has been submitted and processed, an interview will be scheduled with the Preschool Director. All required forms listed below must be turned in before or during the interview. The purpose of this interview is to determine if our school meets the needs of the prospective student and parent and to discuss operational policies. The child must attend this interview and will be given an assessment. Parents will be informed of the Director's decision regarding acceptance into the school program within 3 days of the interview by either letter or phone. No student will be allowed to start school without the required forms listed below.

REQUIRED FORMS:

1. Health and Immunization Form

A completed copy of the "Commonwealth of Virginia School Entrance Health Form" must be submitted either before or at the time of the interview. This form requires that the child have had a physical health exam within the past year and a current certificate of immunization. Forms can be picked up in the preschool office or at the physician's office.

2. Birth Certificate or Passport

Parents must supply an original birth certificate (copies are not acceptable) or a passport as proof of identity. Documents will be recorded in the office for our records and originals returned.

3. Social Security Number or Visa

The child's social security number must be listed on the application for enrollment or a Visa will be required.

WHAT CAN I EXPECT MY CHILD TO LEARN?

The goal of Word of Life Christian Academy's Preschool Program is to achieve the highest potential possible for each child in terms of academic achievement, spiritual growth, social skills, healthy emotional development, and physical performance. Our staff is experienced, well trained, and dedicated to the proper growth and development of your child. At Word of Life Christian Academy we view each child as special and unique in their talents and abilities. In order to accomplish our goals our school uses many interesting and educational activities in the classroom. The A Beka Curriculum is used to promote academic learning. Children participate in Developmental activities that incorporate spiritual, social and emotional maturity and physical development comes through play and exercise.
